## **HRIP** Exam Preparation

#### **Practice Exam:**

This exam is recommended for candidates to identify areas that they need further training on and also to get an idea of the types of questions that could potentially be on the published exam. Once registered, the candidate can take the exam at any time at the convenience of their own computer. The costs for the practice exam are \$75 IHRIM member and \$90 nonmember.

#### The Certification Exam Review Course:

This course is designed to help candidates prepare for the HRIP certification exam. It is not intended to replace professional experience or other sources of achieving professional competence. The key topics and terminology in each of the four (4) main knowledge areas will be covered. An assessment will be given to help the student determine their level of understanding in these knowledge areas.
